#### C. GEORGIA LAW

Georgia law requires that all parties who have made campaign contributions to any member of the Board of Commissioners in excess of two hundred fifty dollars (\$250) within two (2) years immediately preceding the filing of this request and who desire to appear at the public hearing in opposition to the application shall at least five (5) days prior to the public hearing file a campaign contribution report with the Albany Dougherty Planning Commission.

1. <u>25-051 Rezoning</u>: 210 Marie Rd-214 & 216 Adelyn

Raxit Patel (25-051) has submitted an application to the Albany Dougherty Planning Commission requesting that the Official Zoning Map of Dougherty County, Georgia, be amended to rezone four parcels totaling 1.01 acres from C-R (Community Residential Multiple-Dwelling District) to C-2 (Mixed-Use Business District, Conditional). The properties are located at 210 Marie Rd, 214 Adelyn Road, and 216 Adelyn Road. The purpose of the rezoning is to construct a gas station/convenience store. ## 2. 25-054 Rezoning: 905 S. Madison Street
